Membership Secretary's Report

The Committee has stipulated that the total number of Full Members shall not exceed 85. At the AGM in 2015, total membership of the Society stood at 93. This was broken down as follows: 81 Full Members, 6 Country Members, and 6 Life Members. As of 11 May 2016, total membership stands at 88, broken down as follows: 74 Full Members, 7 Country Members, and 6 Life Members. Membership information by category for the past 5 years is summarized in the following table.

A summary of the changes to Society membership for the past year is as follows: 10 Full Members (Derek Buck, Dan Hayden, Martin Hynes, Jonathan Lee, Darren McEntee, Rick Smits, Patrick Tissot-Favre, Alex Van Damme, Sacha Van Damme, and Dave Wilson) and 2 Country Members (Michael Chin and Zac Rosenberg) left the Society. 7 new members were recruited into the Society (Philip Carter, Nigel Farmer, Eugene Lai, Jan Marais, Neil Raymond, Malko Schraner, and Lorenz Zimmerman). 4 members transferred from Full Membership to Country Membership (Graeme Peacock, John O'Doherty, Simon Rudolph, and Larry Lane).

In 2009, the Membership Secretary recommended that Full Membership numbers should not be permitted to reduce significantly below a figure of 75, and for the last two years, our Full Membership numbers exceeded that number. However, numbers are now below this figure. Therefore, over the coming year, we should continue to take the opportunity of recruiting high-quality golfers who meet our stringent joining requirements, subject only to us not exceeding Full Membership of 85.

Next, a reminder of our Rules as they apply to membership:

- All new members must possess a valid HKGA handicap of 18 or less.
- You can only propose AND second one new member each calendar year.
- You must be a member for at least 12 months before you can propose or second a new member.
- Any proposed member must have played at least twice with the Society, one of which must be with a Committee member.
- Anyone who is resident in Hong Kong can only play as a guest three times. There is no limit for guests who reside overseas.

Finally, a perennial request from the Committee with regard to anyone proposed for membership:

- It is very important that the proposer and seconder make the effort to introduce the prospective member to Committee Members at the two competitions before a membership application is considered. This will, at the very least, put a face to a name, and will permit more Committee Members to vote with some knowledge of the candidate.
